

# In the framework of the requirements of law 4/2020 "ON AUTOMATIC EXCHANGE OF FINANCIAL ACCOUNT INFORMATION" as well as Tax Guidelines and Regulations in support of it, every legal entity:

- holder of an account in a Financial Institution, from 01.01.2019 (or onwards);
- holder of an account in a Financial Institution, before 01.01.2019 with a total account or value exceeding USD 250,000 from the last day of each subsequent calendar year;

must declare the tax residence (ies) together with the tax identification number (s) (TAX ID; TIN).

Also, each legal entity or entity that is a passive NFE (Non - Financial Entity) must declare the tax residence (ies) together with the tax identification number (s) (TAX ID; TIN) of the controlling persons (beneficial owner / final shareholder).

#### The following should be considered when completing the form:

- Do not fill out this form if you are an individual account holder;
- Do not fill out this form if you are a financial institution account holder;
- Do not fill out this form if you are an account holder of government entities;
- Do not fill out this form if you are an account holder of an international organization;
- Do not complete this form if you are a corporate account holder whose shares are regularly traded in one or more stabilized securities markets.
- All the data required in point (1) and (2) of the form must be completed.
- If the information provided below regarding tax residence changes after completing this form, then you must complete a new form updated with the data changed within 90 days of the data change and submit supporting documentation accordingly.
- EasyPay Albania Sh.P.K. cannot fill out this form on your behalf.
